### **ASSIGNMENT BACKGROUND**

This surveillance was conducted on behalf of defense counsel in connection with personal injury litigation arising from motor vehicle accident on 07/30/2025. Subject claims significant physical limitations including inability to sit for extended periods, limited walking tolerance,

chronic pain affecting daily activities, and inability to return to work. The purpose of this surveillance was to document subject's actual physical capabilities and daily activities to compare against claimed limitations.

### Claimed Limitations (per medical records):

- · Sitting tolerance: Maximum 45 minutes
- · Walking tolerance: Maximum 200 feet
- · Lifting capacity: Maximum 15 pounds
- · Requires frequent position changes
- Uses assistive device (cane) for ambulation
- Unable to perform activities of daily living independently
- Chronic pain 6-8/10 affecting all activities

- Digital still camera (24MP)
- Audio recording equipment
- GPS tracking for location verification

- Public areas and parking lots

### **INVESTIGATION FINDINGS**

### **Physical Capability Analysis:**

Based on 32 hours of surveillance over 6 days, the following observations contradict subject's claimed limitations:

# 1. Sitting Tolerance:

• Claimed: Maximum 45 minutes

• **Observed:** Sat continuously for 90+ minutes at soccer game without apparent discomfort

Contradiction: Demonstrates ability to sit for extended periods

# 2. Walking/Standing Tolerance:

Claimed: Maximum 200 feet, requires frequent rest

• Observed: Walked throughout large stores for 45+ minutes continuously

• Contradiction: No evidence of limited walking tolerance

# 3. Lifting Capacity:

Claimed: Maximum 15 pounds

• Observed: Lifted 24-pack water (approx. 25-30 lbs), leaf bags (20-30 lbs

each)

• Contradiction: Demonstrates lifting capacity well above claimed limitations

#### 4. Use of Assistive Device:

• Claimed: Requires cane for ambulation

• **Observed:** Used cane only when entering/exiting medical office, not observed during other activities

• Contradiction: Selective use suggests cane not medically necessary

#### 5. Pain Behavior:

• Claimed: Chronic pain 6-8/10 affecting all activities

• Observed: No visible pain behaviors during extended physical activities

• Contradiction: Activities inconsistent with reported pain levels

#### **Behavioral Observations:**

- Subject appeared to modify behavior when approaching medical facilities
- Demonstrated normal gait pattern when not in medical settings
- Engaged in activities requiring sustained physical effort
- · No observed modifications to accommodate claimed limitations
- Activities suggest functional capacity significantly greater than reported

#### SPECIFIC ACTIVITY ANALYSIS

# **Grocery Shopping (12/01/2025):**

Subject spent 45 minutes walking throughout store, pushing shopping cart, reaching for items on various shelf levels, and standing in checkout line. Lifted and carried multiple bags weighing approximately 15-20 pounds each. No rest periods observed. This activity contradicts claims of limited walking tolerance and lifting restrictions.

### Home Improvement Activity (12/03/2025):

Subject examined lumber pieces, lifting 8-foot 2x4 boards above shoulder height to inspect quality. Demonstrated ability to manipulate lumber pieces weighing approximately 10-15 pounds in overhead positions. No

assistive device used. Activity contradicts claims of lifting limitations and overhead restrictions.

### Yard Work (12/05/2025):

Subject engaged in continuous raking activity for 90+ minutes without breaks. Repeatedly bent at waist to collect leaves, lifted filled garbage bags estimated at 20-30 pounds each, and carried bags to curb (approximately 75 feet). This prolonged physical activity contradicts multiple claimed limitations including bending, lifting, and endurance restrictions.

### **Ladder Climbing (12/07/2025):**

Subject climbed 8-foot ladder multiple times while carrying cleaning supplies. Demonstrated balance, coordination, and upper body strength. Performed overhead reaching activities while maintaining balance on ladder. This activity contradicts claims of balance problems, lifting restrictions, and fear of heights that might be expected with significant spinal injuries.

#### INCONSISTENCY SUMMARY

# **Major Inconsistencies Identified:**

- 1. **Selective use of assistive device:** Cane used only at medical appointments
- 2. **Extended sitting periods:** Demonstrated tolerance far exceeding claimed limitations
- 3. **Heavy lifting activities:** Repeatedly lifted objects exceeding stated weight restrictions
- 4. **Prolonged physical activities:** Engaged in sustained work contradicting endurance claims
- 5. **Normal mobility patterns:** No consistent gait abnormalities or movement restrictions
- 6. **Complex physical tasks:** Performed activities requiring coordination and strength

# Implications:

The documented activities suggest that subject's functional capacity significantly exceeds the limitations reported in medical evaluations and legal claims. The pattern of behavior modification in medical settings versus normal activities in other environments raises questions about the validity of subjective symptom reporting.

#### **INVESTIGATOR CONCLUSIONS**

Based on comprehensive surveillance conducted over 6 days and 32 hours of observation, the following conclusions are supported:

- 1. Subject demonstrates physical capabilities that contradict claimed functional limitations
- 2. Activities observed are inconsistent with reported disability level
- 3. Use of assistive device appears situational rather than medically necessary
- 4. No observable evidence supports claims of severe activity limitations
- 5. Subject's behavior pattern suggests awareness of being evaluated in medical settings

#### **Recommendations:**

- Video evidence should be reviewed by medical experts for professional opinion
- Additional surveillance may be warranted during medical appointments
- Consider vocational surveillance to assess work capabilities
- · All evidence should be preserved according to legal requirements
