HISTORY OF PRESENT ILLNESS

40-year-old male presents via EMS following motor vehicle collision approximately 45 minutes prior to arrival. Patient reports being the driver of a vehicle that was struck on the driver's side by another vehicle at moderate speed. Patient was wearing seatbelt, airbags deployed. Denies loss of consciousness. Primary complaints include severe left hip pain, neck stiffness, and lower back pain. Patient reports 8/10 pain in left hip, 6/10 neck pain, and 7/10 lower back pain.

VITAL SIGNS

BP: 142/88 mmHg

HR: 98 bpm

RR: 20/min

Temp: 98.6°F

O2 Sat: 98% RA

Pain: 8/10

PHYSICAL EXAMINATION

General: Alert and oriented x3, appears uncomfortable, in moderate

distress

HEENT: No obvious trauma, pupils equal and reactive

Neck: C-spine tenderness, limited range of motion, no step-offs palpated

Chest: Clear to auscultation bilaterally, no crepitus

Abdomen: Soft, non-tender, no guarding

Pelvis: Stable to compression

Left Hip: Shortened and externally rotated left lower extremity, severe

tenderness over greater trochanter, limited active range of motion

secondary to pain

Back: Lumbar spine tenderness, paraspinal muscle spasm

Extremities: No other obvious deformity, pulses intact

DIAGNOSTIC STUDIES

X-rays:

- Left hip (AP/Lateral): Displaced intertrochanteric fracture of left femur
- Cervical spine (5-view): No acute fracture or dislocation
- Lumbar spine (AP/Lateral): No acute fracture, mild degenerative changes
- Chest X-ray: No pneumothorax or hemothorax

Laboratory:

• CBC: WBC 12.3, Hgb 13.8, Plt 285

BMP: Normal

PT/PTT: Within normal limitsType and screen: O positive

ASSESSMENT AND PLAN

Primary Diagnosis: Left intertrochanteric hip fracture (S72.141A) **Secondary Diagnoses:** Cervical strain (S13.4XXA), Lumbar strain

(S33.5XXA)

Treatment Plan:

- 1. Orthopedic surgery consultation for operative management of hip fracture
- 2. Pain management with morphine 4mg IV q4h PRN
- 3. NPO in preparation for surgery
- 4. Cervical collar for comfort
- 5. DVT prophylaxis with sequential compression devices
- 6. Pre-operative labs and consent obtained
- 7. Patient admitted to orthopedic service
